# MINUTES OF THE PAYNE COUNTY ELECTION BOARD February 13, 2024

The Payne County Election Board met in a Regular meeting at 10:00 a.m. at the Election Board office located at 315 W. 6<sup>th</sup>, Suite 207 in Stillwater. A written notice was filed with the County Clerk on November 27, 2023, along with posting an agenda at the Election Board office on February 7, 2024. A copy of the agenda and notice are attached.

Walraven called the meeting to order at 10:19 a.m. with a quorum present.
